THE FRANK G. CAMPBELL OUTSTANDING SERVICE AWARD

In recognition of outstanding industry, Association and public service!

THE AWARD: A symbolic representation of outstanding service characterized by the criteria of the Award.

CANDIDATES: Any motor carrier member in good standing of the Missouri Trucking Association (MoTA) having been engaged in a career in the trucking industry or a related activity thereof.

NOMINATIONS: Made by any two motor carrier members in good standing of the Missouri Trucking Association. Nominations must be received plainly marked on the envelope as to its contents, at the MoTA headquarters office by **August 26th, 2022.**

PROCEDURE: Nominations shall be made in manuscript style, typed copies giving only the information concerning the candidate within the three criteria considered in the judging. No photographs shall be included and the candidate's name shall appear nowhere in the manuscript, but shall be included only on a plain white flyleaf attached to the manuscript.

JUDGING: Judging will be by three persons of recognized stature in their respective fields removed from the trucking industry. The names of the candidates will be unknown to the judges; only the winning candidate's name will be made public.

CRITERIA: The form prescribed for the nominations and upon which judging will be based is:
