Why Should I Participate?

Every successful safety program consists of three important components. First is a strong and knowledgeable safety director to implement safety programs to ensure the company is compliant and profitable. Next, to achieve safety goals, the safety director needs the full support of the safety programs from upper level management. And thirdly, drivers, who personify the public's perception of the company, must provide total cooperation to the safety programs. *If any of these ingredients are missing, the program will fail and the motor carrier becomes subject to intervention.*

Participation in the Missouri Trucking Association's Council of Safety Supervisors and attendance at sponsored events is paramount to maintaining a successful safety program. Monthly meetings offer top notch programs and an opportunity to network with other safety directors. In addition, participation in the Council of Safety Supervisors familiarizes your company personnel with Council and Association sponsored award and incentive programs. Most of these programs are available at no charge.

Council Sponsored Awards Programs

Driver of the Month/Year: Twelve drivers are honored each year for outstanding achievements. One is selected as the Missouri Driver of the Year to compete at the national level.

Fleet Safety Contest: Trucking companies compete for recognition in four classes based on mileage and accidents over a one year period.

Truck Driving Championships: Annual contest of driver skill and knowledge. Winners go on to compete with other state winners at the national level.

Safety Director of the Year: Honoring one safety professional for performance in the pursuit of company and industry truck safety.

Chairman's Safe Driver Club: Recognizing safe driving records of drivers submitted and verified by company safety professionals.
