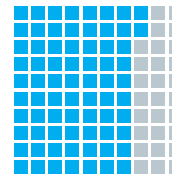


#### SMALL BUSINESS EMPHASIS



Trucking companies located in **Missouri** (2017). Primarily small, locally owned businesses, these companies are served by a wide range of supporting businesses.

#### TRANSPORTING THE ESSENTIALS



**72.4%**

of Missouri communities depend exclusively on trucks to move their goods.



Percent of total manufactured tonnage transported by trucks in the state. **That's 263,518 tons per day.** (2012)

#### COMPETITIVE WAGES

- Total trucking industry wages paid in Missouri in 2016 exceeded **\$6.6 billion**, with an average annual trucking industry salary of **\$46,996**.
- Heavy and tractor-trailer truck drivers held **42,400** jobs with an average annual salary of **\$42,460** (U.S. Bureau of Labor Statistics, May 2016).

#### COMMITMENT TO SHARING THE ROAD



The **Share the Road** program sends a team of professional truck drivers to communities around the country to teach car drivers about truck blind spots, stopping distances and how to merge safely around large trucks, all designed to reduce the number of car-truck accidents.

### \$ TRUCKING PAYS THE FREIGHT

#### THE INDUSTRY

**\$680 million**

Amount the trucking industry in Missouri paid approximately in federal and state roadway taxes (2016).

The industry paid **40%** of all taxes owed by Missouri motorists ...

... despite trucks representing only **13%** of vehicle miles traveled in the state.

#### INDIVIDUAL COMPANIES

As of January 2017, a typical five-axle tractor-semitrailer combination paid:

**\$4,447** + **\$8,906**  
 state highway user fees and taxes federal highway user fees and taxes

These taxes were over and above the typical taxes paid by businesses in Missouri.

### TRUCKS DELIVER A CLEANER TOMORROW

#### EMISSIONS

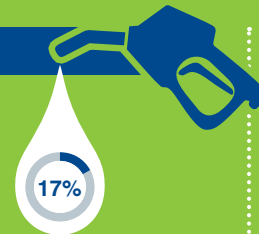
Through advancements in engine technology and fuel refinements:

- ✓ New diesel truck engines produce **98%** fewer particulate matter (PM) and nitrogen oxides (NOx) emissions than a similar engine manufactured prior to 1990.
- ✓ Sulfur emissions from diesel engines have also been reduced by **97%** since 1999.

#### FUEL CONSUMPTION

The trucking industry continues to improve energy and environmental efficiency even while increasing the number of miles driven. In 2016:

- Trucks accounted for just **17%** of the total highway transportation fuel consumed.
- Trucks consumed **100 billion** fewer gallons of fuel than passenger vehicles in the U.S.



#### PARTNERSHIPS



Through the **U.S. Environmental Protection Agency's (EPA) SmartWay Transport Partnership**, the trucking industry is working with government and businesses to quantify greenhouse gas emissions and take steps to reduce them.
